Applications are invited from eligible candidates for engagement of one Special Public Prosecutor (SPP) to handle the cases related to Central Excise & Service Tax, Dhanbad Commissionerate before the Subordinate Courts/Courts of Session and High Courts in prescribed proforma (Annexure A).

A. Terms & Conditions:

(1) Nature of work: To represent the cases relating to Indirect Taxation before the Subordinate Courts/Courts of Session/High Courts.

(2) Eligibility: The person should have been in practice as an advocate for not less than ten years as a Special Public Prosecutor.

(3) Tenure: The first appointment of Special Public Prosecutor shall be normally for a period of 18 months.

(4) Termination of appointment: The appointment/empanelment of the Special Public Prosecutor would be terminable on one month's notice in writing by either side without assigning any reason.

(5) Fees & Allowances: It will be paid as per CBEC's letter F. No. 278A/82/2008-Legal, dated 25th May, 2010 or as revised by Board from time to time.

(6) Other Terms & Conditions: The appointment of aforesaid advocate as Special Public Prosecutor shall be subject to the terms & conditions as laid down in CBEC's letter F. No. 278A/82/2008-Legal, dated 25th May, 2010 or as revised by Board from time to time.
